Blogs and Bullets

"Blogs and Bullets" is the name of an ongoing series of events and research papers supported by nearly \$200,000 in grants from the United States Institute of Peace.

Evaluating the Impact of New Media on Conflict

The first Blogs and Bullets event took place in Washington D.C. on July 8th. The event focused around a special report released at the conference, in which a team of scholars from GWU, in cooperation with scholars from Harvard's Berkman Center for Internet and Society and from Morningside Analytics, took a fresh theoretical, and empirical approach to discussing new media in conflict areas. The report critically assessed both the "cyberutopian" and "cyberskeptical" perspectives, and proposed a new framework for assessing the role of new media in contentious politics.

This event explored these themes in three panels. In the first morning panel, Alec Ross of the U.S. State Department, Berkman's Ethan Zuckerman, and GWU's Marc Lynch engaged in a discussion of these topics moderated by USIP's Sheldon Himelfarb. The second morning panel featured bloggers and citizen journalists from around the world to offer a ground-view perspective. The final panel brought together tech firms eBay and Facebook to explore their perspectives on new media and conflict.

New Media and the Former Soviet Union

During this daylong event cosponsored with the International Development Forum and in partnership with the Institute for Russian and Eurasian Studies, the Institute for Development Studies, and Internews, panelists discussed the role of social media and new technology in former Soviet States.

Topics of discussion ranged from crowd sourcing in Russia to new journalism in the Caucasus and the use of the blogosphere in conflict zones. Global Communication M.A. alum, Gregory Asmolov was featured on one of the panels.

New Media and the Struggle for Political Change

The second Blogs and Bullets event occurred in Palo Alto, California at Stanford University on February 24th. Following a series of workshops, a public event was held at which presenters discussed many aspects of new media, from crowd sourcing to social networking, diplomacy 2.0 to private sector approaches to new media.

On September 22nd, the IPDGC hosted a brown bag discussion with Professor Victoria Levinskya, a visiting Professor from Westminster University in Tashkent, Uzbekistan and Senior Diplomacy Fellow Mark Asquino.

Professor Levinskya introduced the political and social environment of Central Asia and Uzbekistan before discussing Islamic traditions in Uzbekistan, the relationship between state and religion, women in Islam, and contemporary political Uzbek Islamic groups.




Act of Dishonor

Dr. Slaughter touched upon the many difficulties and opportunities of the State Department's development and diplomatic operations. She also elaborated on the importance of empowering civilians and partnering with the private sector to meet development goals and ultimately engage in productive public diplomacy.

Anne-Marie Slaughter is the Bert G. Kerstetter '66 University Professor of Politics and International Affairs at Princeton University. At the time of the talk, she was on leave and serving as director of policy planning for the United States Department of State.



After the Vote

Promises and Pitfalls in Post-Referendum Sudan

On Thursday, February 17th IPDGC, along with the Pulitzer Center on Crisis Reporting, hosted a panel discussion, "After the Vote: Challenges and Opportunities for a Two-State Sudan," featuring panelists were Pulitzer Center journalist Rebecca Hamilton and experts Jon Temin and Cameron Hudson. The panelists provided a unique perspective on the current status of Sudan after the vote for independence in January and on the future of the two new nations.

In addition to the panelists, Fathelrahman Ali, the acting chargé d'affaires of the Embassy of the Republic of the Sudan and Ezekiel Lol Gatkuoth, the head of mission of the Government of Southern Sudan in the United States, addressed the necessity of cooperation and peace to ensure success for the two nations.

Media and U.S. Governance Seminar

In November, IPDGC welcomed back a delegation from the Chinese Office of the Spokesperson for the second weeklong seminar exploring the press-state system in the United States.

Visiting delegates attended lectures given by GW faculty members that discussed topics ranging from the role of government in media and censorship to the evolving relationship between media and technology. The delegation also visited the State Department, where they sat in on a press briefing with the Assistant Secretary for Public Affairs, P.J. Crowley.

This was the fourth year that the IPDGC had worked with the People's Republic of China on media training.


Navigating the U.S. Media with P.J. Crowley

Election Coverage in Revolutionary Egypt

In April, IPDGC Director Sean Aday, and Trachtenberg School professor Bill Adams, were invited to speak on a panel at the American University in Cairo about the coming elections in Egypt following the successful January 25th protests that ousted longtime dictator Hosni Mubarak. Aday and Adams also ran an all-day workshop for Egyptian journalists on how to cover elections and politics in general.

"It was an incredible experience," Aday said. "You could feel the sense of hope mixed with worry about how things are going to play out. It was great to be in Tahrir Square, which still had dozens of people holding signs and arguing politics, and talk to Egyptians about the future of their country."

After the Quake

The Institute for Public Diplomacy and Global Communication partnered with the School of Media and Public Affairs and the Pulitzer Center for Crisis Reporting to bring together journalists and media experts to discuss conflict reporting in Haiti after the devastating earthquake in 2010.

Visiting speakers included Kwame Dawes, William Wheeler, Lisa Armstrong, and Stephanie Hanes.

The IPDGC brought journalists to classrooms at GW where they talked with students about their professions and experiences. This visit culminated in a public event on October 20th where the speakers presented to an audience of students, faculty, journalists, and other guests.

Tackling the Threat: the Lord's Resistance Army

The IPDGC joined together with Human Rights Watch and the Pulitzer Center for Crisis Reporting for a night of heart-wrenching stories, political analysis, and a thorough discussion of the media in conflict zones.

The packed Jack Morton Auditorium housed our special presentation on the Lord's Resistance Army, and related atrocities committed in central Africa. Through their images, videos, and anecdotes, Pulitzer Center journalists Joe Bavier and Marcus Bleasdale and Human Rights Watch researcher Ida Sawyer and senior researcher Anneke Van Woudenberg related their findings and evaluated whether President Obama's new strategy to tackle the LRA could bring success.



The Walter Roberts Endowment



The Walter Roberts Endowment

PDGC operates in large part on the generosity of Dr. Roberts. Roberts is a foreign policy consultant and a former Foreign Service officer who began his public diplomacy career with the Voice of America and retired as associate director of the U.S. Information Agency (USIA), then USIA's top career position. He was appointed by President George H.W. Bush and reappointed by President Bill Clinton to the U.S. Advisory Commission on Public Diplomacy. He taught public diplomacy for 10 years at GW's Elliott School of International Affairs. Roberts is the author of the book, *Tito, Mihailovic and the Allies, 1941-1945*, and numerous articles on foreign policy and public diplomacy. He is a member of the Council on Foreign Relations and the Washington Institute of Foreign Affairs and served on the board of The George Washington University's Public Diplomacy Institute.

Roberts received a Ph.D. from Cambridge University. It was Roberts' idea to establish a Public Diplomacy Institute at GW, originally directed by Prof. Steven Livingston at GW's School of Media and Public Affairs. In 2005, Roberts generously created an endowment in his name for the Institute.

The Walter Roberts Endowment Award

Akash Suri, a graduating Global Communications M.A. student, has been named the recipient of the inaugural Walter Roberts Award for the Study of Public Diplomacy, an honor co-sponsored by IPDGC and the Walter Roberts Endowment Board.

The award carries with it a \$1,000 prize, and recognizes a student who has performed at a high level in and out of the classroom, especially in public diplomacy-related work, and who has an interest in pursuing a career in public diplomacy.

Among his many accomplishments, Suri has worked at the State Department as an online community specialist and Regional Affairs intern, and has worked in the past at the Broadcasting Board of Governors, the U.S. Embassy to India, and the U.S. Mission to the United Nations. He currently has a GPA of 3.94 and 4.0 in Public Diplomacy Concentration courses.

"We had a strong field of applicants for this award, but Akash really stood out even among such a talented group," said IPDGC Director Sean Aday. "Akash is a terrific student, very bright and original in his thinking about public diplomacy, and already has an impressive public diplomacy resume."
